Conservative Association Chairman's Report to Members

The last few weeks have been difficult for us politically and personally, and emotions have been running high.

The Best Value Inspection report into the running of Northamptonshire County Council makes for difficult reading. The recommendations are stark. The inspector has recommended that Commissioners are brought in to take over the running of all areas of Council except planning, and that the County Council should be abolished and two new Unitary Authorities established.

That means the abolition of all the District and Borough Councils too!

If the inspector's recommendations are carried out, which is likely, that will mean a North Northamptonshire Unitary Authority being set up in our area. It will cover the area of Corby, Kettering, Wellingborough and East Northants.

Town Councils will become more important, as they take on more responsibilities and control of larger budgets. New Town Councils will have to be formed in Wellingborough, Corby and Kettering.



The District and Borough elections of 2019 will not now take place, current Councillors terms will be extended by a year. The elections for the new Unitary Authority will take place in 2020.

Now is the time for us to come together and be proactive about shaping the future Unitary and Town Councils. There are many questions to be answered, from the number of Councillors, to area Committees, to Committee or Cabinet structure, who will be appointed to the Shadow Authority, and so on.

I know it is difficult, but we now need to stop thinking in terms of East Northants, Corby, Wellingborough and Kettering. We must start thinking about ourselves in terms of the whole of the new North Northamptonshire area.

If we sit back and do nothing, a new structure of local government will be imposed on us from Whitehall. Let's work together to get the best for our residents and our area.

NORTHAMPTONSHIRE COUNTY COUNCIL

Following the Best Value Inspection (Jan-Mar 2018) of Northamptonshire County Council the report has now been published and is available online. The report was critical of the council and has made a recommendation that a unitary form of local government should be introduced. A brief note of the main comments of the 50 page report of the recommendation are below:

A way forward with a clean sheet, leaving all the history behind, is required.

Moving to a unitary form of local government has been discussed in the county for some time. There has been no meeting of minds between the two tiers of local government, not surprisingly given the relationships. The county has promoted a single county unitary, with effectively them in control, whilst the second tier have either wished to remain as the status quo or looked at a 2 or 3 unitary model.

In meeting the inspection team, Borough and District Leaders recognised that whilst their individual councils might prefer a status quo option what matters is what delivers the best result for the people of the county starting from where we are and that some model of unitary local government is now the only viable option.

The above article is published not as a critique of the Council but purely to enable members to see a brief summary of the recommendations without having to wade through the very lengthy report..

Our local Member of Parliament, Tom Pursglove has posted his comments about this matter on Facebook and they are reprinted elsewhere in this magazine.



It would be necessary to establish a council size which complied with the Local Government Boundary Commission for England's guidance but in the experience of the inspection team 45 members each would be appropriate

It is the inspection team's clear view and recommendation that in the particular circumstances that the county finds itself in the two unitary (West and North) model is the preferred way forward, with a view to the first elections for the new authorities taking place in May 2020 who would come into effect at their first annual meeting.

In the meantime, given the significant challenges that the council and its officers face, the Secretary of State should give serious consideration to NCC services, with the exception of planning, being run in some configuration by Commissioners with the full powers of the council to maintain the position in a safe, lawful and value for money way whilst the shadow authorities work to establish the proposed new unitary councils.

The District and Borough Councils will be putting forward their own proposals based on the report's recommendations.

Later this year, on the 22nd April, I will be running the London Marathon for the first time. This has been something that I have thought about doing for a while and, despite the nerves and the sore feet from the training, I am really looking forward to the challenge - he says now!

The London Marathon is like no other - it is essentially a very British celebration and raises millions of pounds each and every year for good causes across the country. I will be running in aid of two fantastic local charities - Corby Nightlight and Crazy Hats Breast Cancer Appeal - which do so much for people in our area.

I have seen the work that Corby Nightlight does first hand, as well as raised their important efforts to support homeless people in our community in the House of Commons and with Ministers, and I am currently actively supporting their bid to secure new, fit-for-purpose premises, in which to operate, and I hope that the money I raise will help with this important work. Crazy Hats Breast Cancer Appeal is also a charity that I have long supported, and which supports all aspects of breast cancer care, here in Northamptonshire. Crazy Hats was founded in 2001 by the remarkable Glennis Hooper, and has since raised over £2 million for breast cancer care, and given £900,000 to Kettering General Hospital, and I am so pleased to be able to play my part in supporting their work once again. I can't think of anyone more inspirational than Glennis and the thought of letting her and the charity down will help to focus the mind in the latter stages on the day - I'll have to keep going!

One of the lesser-known things about being a Member of Parliament is that you are granted



automatic entry into the London Marathon by the organisers, without having to be drawn in the ballot - something which can take years! This is all organised with the help of the London Marathon team and the All Party Parliamentary Group (APPG) on Running, of which I recently became the Chairman. The Running APPG is a cross-party group to encourage running as a sport, and to inspire more people to take it up across the country, and the Marathon is unsurprisingly one of the biggest events in the calendar. This year, there have been a record number of MPs sign up to run the London Marathon – the count currently stands at 21, including me, and fingers crossed everyone will make it to the start line without injury!

It has been a bit of a challenge to fit marathon training around my parliamentary commitments - often squeezing in a quick run either early in the morning, or late at night - but with a practice half marathon coming up this weekend, my training feels like it is going according to plan. It would be great to hear from any of my constituents who are also running the London Marathon, and to hear how your training is going, and to everyone taking part in our area, "good luck"!

Councillor Helen Howell is Chairman of this group and a meeting was held on 20th February 2018 at which 8 people attended. The analysis, which has been sent to CCHQ, is reproduced below:

Q1. Whose responsibility should training be: the citizen, schools and universities, the employer, the state, or all of them?

A2. **Training** should start in schools but with more emphasis placed on desirable business skills and specialist career advice. The military model was considered to be a good one as it gave opportunities to individuals in return for service, which as a model is mutually beneficial. A similar model for businesses could involve companies sponsoring degrees in return for learners making a time commitment to the sponsor with repayment of fees should they leave. The government could encourage sponsorship from specific sectors that have a shortage of skills with incentive such as tax breaks. Universities and colleges should condense their courses and offer on the job training such as sandwich years. There should be a smart recruitment process to encourage students to remain in the sector with a paid trial period prior to commencement of the sponsorship over the summer period. There should be more involvement with the schools by employers from the start.

Q2. How might a Conservative Government seek to boost productivity across the UK?

A2. **Productivity** can be boosted with further improvements to the

country's infrastructure, road, rail etc to improve access to materials, buyers, sellers and employment. There needs to be the right pay for the right job and employers need to encourage employees with job opportunities, responsibilities, training opportunities and motivation by investing in people. This in turn will attract people to those sectors; the government can encourage sectors where we need skills with tax breaks for investing in those people through training or getting involved with sponsorship.

Q3. In what ways could the UK build on its world-class reputation for training and expand opportunities for lifelong vocational education and training?

A3. We definitely need a **sector led bottom up approach** to a national skills programme. Training needs analysis of individual sectors can be carried out by a body such as The Sector Skills Council - where there is one specific specialised body representing each sector. Importantly these Sector Skills Councils should represent the business within their sector, rather than simply be commercial membership organisations that need to sell to their members to survive.

Q4. In what ways does training need to catch up with the changing skill requirements of modern technology? Are there any new and innovative models of training in your area that could be used elsewhere?

A4. There should be targeted teacher training with **more focussed teacher training days led by experts**, and training days should be held during school holiday time NOT during school term time. There should be more new technology used in the classroom and students should be shown new technology as

it is introduced. There should be a Training Board with courses for teachers to attend and upskill themselves in new technology. Again we need to engage with the Sector Skills Councils to gain advice. Educators need to look at other forms of training such as e-learning to form a blended learning solution. We need the right training with the right method. Investment in new technology for schools is vital. We need to engage with employers to get involved and advise schools.

Q5. How should a Conservative Government deal with possible widening income gaps arising from increased automation?

A5: **An analysis for future needs in training** should be conducted to enable us to be ready for the future. Opportunities for the workforce to re-train for alternative positions within the sector or new skills should be encouraged. Re-training / further training should be offered as part of all redundancy packages. To encourage training and advancement we should reduce money for nothing.

Q6. What policies should a Conservative Government adopt to balance the need for improved training and productivity in the UK with any desire to reduce our reliance on skilled technical expertise from abroad? How might these be paid for?

A6. There needs to be tax breaks for training to keep it in house, providing opportunities in this country, Improve our trainers and training opportunities. Invest in 'train the trainers' in schools, colleges, universities and the business sector. **We need to import knowledge not people.** We are already paying for training in this country, we need to ensure the funding is directed in the right way.

This was our first CPF meeting since before the last election and everyone attending said that it was a really good event and they are looking forward to the next. We plan to alternate the meetings between the Raunds and the Corby Conservative Clubs.

The move will strengthen fears of a hard-Left purge of Labour moderates, with the influence of Momentum increasing in recent months.

Sir Robin recently criticised Mr Corbyn's leadership, saying the party should be ahead of the Conservatives in the polls.

Jeremy Corbyn has been branded a hypocrite after it emerged he goes to work in a chauffeur-driven gas guzzling diesel car - despite proclaiming himself an environmentalist.

The Labour leader takes the seven-seater people carrier to work in Parliament even though it is just a short tube journey away from his Islington home.

The revelation comes after his own Labour-run council last week called for diesel cars to be banned because they pump out deadly toxins.

And it has been claimed the Labour leader left the Ford Galaxy waiting on a double yellow line outside his north London home for 40 minutes on Tuesday before making the six-mile journey to Westminster.

Mr Corbyn eventually left home just after 9.32am, but headed off towards the shops before coming back to the car five minutes later, it was reported.

Mr Corbyn was offered a chauffeur-driven car by the Government Car Service when he became Leader of the Opposition in 2015.

But he is not obliged to use it and ministers have turned down using their cars previously.

Former Tory MP Andrew Percy criticised the move at the time, saying: 'Jeremy Corbyn's supporters on Twitter are trolling people about privilege but at the first sniff of a perk, Jeremy Corbyn succumbs to a taxpayer-funded car. He should do what the rest of us do - get a standard rail ticket or walk.'

Tory MP Andrew Bridgen last night accused the Labour leader of 'breathtaking hypocrisy'.

He told The Sunday Express: 'He's like one of the old Soviet leaders, riding around in his Zil while the rest of his comrades are on bicycles,' he said.

'Once again it's a case of do as I say, not as I do. It's clear Mr Corbyn is one of the few not the many whom he lectures.'

Last week Islington Borough Council and the neighbouring Labour-run authority Hackney, proposed a ban on diesel cars with drivers flouting the air pollution crackdown facing £130 fines.

Mr Corbyn has spoken out against polluting diesel cars which he warns are creating air pollution which is killing children.

The DVLA database reveals Mr Corbyn's mode of transport emits a hefty 189g of carbon dioxide, putting it in the fourth highest vehicle tax band.

Tom Purglove MP on the NCC

Yesterday, the Inspector published the findings of his 'best value' inspection of Northamptonshire County Council, which was instigated by the Secretary of State, not least following significant concerns having been raised by the seven Northamptonshire Members of Parliament. As such, I thought it would be helpful to share our joint response here, issued in light of this news:

"We welcome and endorse the Max Caller inspection report on the County Council. It was thorough, hard hitting and sometimes made uncomfortable reading, but it was badly needed and it has come to the right conclusion. The County Council was hit by a perfect storm of poor leadership in a financially challenging environment. Now is not the time to keep scrabbling around. The days of complex two tier local government in the County are at an end. We need to strike whilst the iron is hot for two unitaries as the solution set out by the report. We MPs were quick and direct in calling for this inspection and demanding action. The County Council ultimately ran out of time fuelled by poor management and indecision. It is imperative that we do not make the same mistake again. Time needs to be used wisely. For the sake of our constituents, who rely on local services, the County Council needs to be abolished and a new local government model created in its place."

Moving forward, the issue of local government reform locally will undoubtedly be at the fore and as I have emphasised for some time, I want to see local councillors and the communities they represent, work constructively and innovatively to get the detail of the future model the best it can be for our area.



For some months I have suspected that there will be a move towards local government reform and have raised, including on the floor of the House, a number of key points, that I believe must be carefully considered as part of this process. In particular, we should focus on making the case that the reserves diligently and responsibly accrued by the existing districts and boroughs should be spent to the benefit of the communities where they were generated. Second, that the model should ideally revolve around a committee system rather than a cabinet model - recognising the flaws that have happened under the current model at County Hall, and given it is more inclusive and does not concentrate power in the hands of just a small handful of senior councillors. Finally, that the model enshrines strong area representation; making sure, for example, that wherever possible, Corby people take decisions that directly affect Corby, and likewise in East Northamptonshire.

As I say, these are all points I have been making for some time, having foreseen the potential need for reform, and I will continue to engage proactively with all local councillors - regardless of party - and local people, to make sure we shape the future model of local government for our area, so it best meets local needs, and respects the unique identities of our communities.

Conservative Home - On BREXIT

I keep trying to move on from Brexit. Twenty-seven years is more than enough time to spend on any issue, whatever its importance. But, just at the moment that the question should have been definitively settled, everyone else is becoming obsessed with it.

Everything – everything – is seen through the prism of the 2016 referendum. The debates we ought to be having about regulation, tax, agriculture, fisheries, regional policy, public spending and the rest are cribbed, cabined, confined by the parameters of Brexit. The argument about where to draw the line between competitiveness and employment rights is measured solely by the yardstick of divergence from EU standards. The issue of farm subsidies is judged, not on its merits, but by whether scrapping the CAP is advantageous. The unexpected budget surplus has not led to a measured debate about the level of public spending, but to a predictable chorus of “Where’s our £350 million a week, Brexshit liars?” Both sides are to blame for the polarisation.

People who couldn’t have told you what the Customs Union was last year now insist that staying in it is the single most important issue in politics.

Continuity Remainers are not simply lamenting the result. They are encouraging the EU to offer bad terms in the hope of triggering a second referendum – often with shocking flagrancy. When Michel Barnier welcomed the clarity of Theresa May’s detailed speech on the ideal exit terms last month, Lord Adonis tweeted as follows: “Dear M. Barnier, it’s increasingly likely that the British people will hold a referendum on Mrs May’s Brexit deal & many of us look forward to Britain playing a leading role in the EU long after 2019.” In other words, if you’re hardline enough, we might just drop the whole idea of Brexit. Alastair Campbell was even more explicit, telling the Irish Taoiseach to “Play hardball, Leo”.

It’s odd to watch Campbell, the spin doctor’s spin doctor, pursuing a policy that he would surely advise any client against. About the worst look in politics is to be seen to be siding against your own country – especially if you are going out of your way to define a negotiation as confrontational when your government wishes it to be friendly. It is unwise to insult 17.4 million people, to call them old and ignorant and bigoted, to wish for their deaths so as to change the demographic balance. It is unwise to be photographed with the people on the other side of the table. It is unwise, above all, to be seen to be hoping for an economic collapse. Remainers have broken every one of these rules, which is why they would struggle to win a second referendum.

But that’s not how it is seen in Brussels. Even now, many Eurocrats believe that, if they make Brexit painful enough, we might drop the whole idea. That, after all, has been their experience with previous referendums in the Netherlands, France, Denmark and Ireland. Their demand that we should accept most of the burdens of membership with no veto rights is not a serious negotiating position. It’s not even a serious opening bid. It’s an attempt to browbeat us into changing our minds.

The trouble is that, as long as a chunk of our politicians and pundits are set on overturning the referendum, and as long as they keep telling Brussels to hang tough, the EU has little incentive to discuss a mutually beneficial outcome. This makes the process of extrication, if not the eventual outcome, more fraught and costly than it need be.

The notion that we might be worn down is an odd one. I know that people tend to believe what they want, and Brussels officials understandably like to listen to Nick Clegg and Tony Blair and all the others who have so far been unremittingly wrong. But if they think we can be bullied into changing our votes, they really don’t understand us at all.

In today's (21/3/18) Prime Minister's Questions, I raised the issue of disposable paper coffee cups, millions of which tragically go to landfill worldwide every minute - an issue which has attracted very significant media attention in recent months, and something a considerable number of constituents have contacted me about, raising their concerns and urging government to take action. As such, I was delighted, when I visited Amaray, a Corby based company a few weeks ago, when they told me they had developed a 100% reusable, 100% recyclable, and cost effective, plastic alternative to these paper cups, that are far easier to recycle and can be recycled through standard curb-side recycling schemes, rather than going to landfill. BERLIN TIME MAY BE COMING (from the Mail on Sunday)

The proposed EU rule change would end the ritual of moving clocks forward by an hour in March and back again in October – which happens all over Europe on the same day.

It is being debated by MEPs after an ‘impact assessment’ indicated ‘the existence of negative effects on human health, agriculture and road traffic safety’.

Although the Government would be able to block the move through the European Council up until the moment of Brexit in March 2019, ‘Berlin Time’ could theoretically be imposed on the UK during the following transition period if the negotiated terms for that period oblige us to accept Brussels rules with no power to veto.

And even post-transition, it would leave the UK having to decide whether to scrap the biannual clock change anyway – in order to keep the same hour’s time difference with the rest of Europe – in effect, Greenwich Mean Time all year round.

Otherwise, for six months each year, London would find itself on the same time zone as Berlin. Ie, Central European Time.

The EU move comes seven years after The Mail on Sunday mounted a successful campaign against an attempt by British MPs to move our clocks forward by an hour. The doomed plan triggered a furious debate about the pros and cons of the change in terms of stress, mental illness, pollution, road accidents and energy consumption.

The new European Parliament resolution says that ‘numerous scientific studies... have failed to provide proof of any positive effects of the biannual clock change’.

Research cited in the resolution, tabled by French MEP Karima Delli, claims that in the days after the clocks are changed, elderly people face an increased danger of heart problems, while road accidents increase by up to a third. The academic performance of children, it says, is also affected because ‘the human body is made for a steady biorhythm’.

The practice of changing the clocks has already been ditched in some countries, including Iceland, Belarus and Turkey.



Another option being discussed to retain long summer evenings is to move to EU Summertime – GMT plus In February. Ukip MEP Nathan Gill warned: ‘If the EU decides to scrap daylight-saving time, it would leave Britain with a major question post-Brexit.

‘If legislation happens during transition, we could be lumbered with whatever the EU decides to pass, despite what our farmers or accident prevention organisations think.

‘There is also the risk that the EU could force Britain to change its time to an hour ahead of GMT to align with the Continent before we Brexit, when this should be a national debate.’

POLICE AND CRIME COMMISSIONER STEPHEN MOLD

Setting the annual budget for any public service is a complex and challenging undertaking. With the growing pressures on public services across our country, setting this year's budget has been no exception. Having spoken to people in the county personally and having heard from over a thousand residents as part of our Public Perceptions Survey, I know that people in Northamptonshire are happy to contribute to help create a first-class policing service and a safer county.

An extra £1.00 per month for those in a Band D property will deliver an extra £3.97million for the policing budget, which will allow Northamptonshire Police extra resources for areas such as proactive



intelligence and domestic and sexual abuse investigations. I will also set aside money to tackle rural crime, invest in road safety and prevent crime at its root through early intervention initiatives.

Policing resources have been cut, cut and cut again in recent times but it is vital that

this isn't allowed to continue, for the safety of our people and our communities. I have been heartened by people's attitudes to understanding the value behind policing and being prepared to contribute more to ensure we start to reverse this trend.

I have been extremely vocal in saying that as a county we do not receive a fair funding settlement from central government when you consider the size of our population and our geographical area. In addition to this, we were told late last year that there would be no increase in funding for policing coming from the Home Office. Achieving a fair funding award for Northamptonshire is a battle I will continue to fight to ensure that we support our police force with the resources they need to continue to protect people from harm.

I have spent a great deal of time lobbying central government to recognise the weaknesses in the way policing nationally is funded and how Northamptonshire Police has been historically underfunded which has placed real pressures on the delivery of front line policing. When the settlement was announced last year, I was encouraged that the government seemed to be listening to the concerns that we have been putting to them over the last twelve months about the funding issues we have been facing.

The Government's announcement that there will be more money for counter terrorism and public protection is welcome, however it is somewhat disappointing that police forces across the country were told to expect a flat cash budget.

In other words, no more money for frontline policing in Northamptonshire. Whilst I recognise that there is only a finite amount available from central government, I am not completely satisfied with our budget allocation.

However, for the first time, the Government have given PCCs more flexibility to raise funds locally following an increase in the amount they can raise through the council tax precept. In the medium term, if I increase the precept by £1 per month in 2018/19 and 2019/20 and the Force find efficiency savings, I can deliver over a balanced budget. However, after that time, at current demand levels, there is a shortfall of over £2.6m on the Medium Term Financial Plan, but we know the demands and challenges will continue to increase further in future years. This year's budget has been a very challenging undertaking and the decision to increase the precept was not taken easily. I do feel as if PCCs have had their hands forced by the government's decision to allocate a flat cash budget which effectively leaves a funding gap for PCCs to fill.

I am now looking forward to the conclusion of the review which is looking at how policing is funded across the England and Wales. I am hopeful this will yield a better outcome for Northamptonshire in the long term.

We currently get a raw deal for money per head of population in comparison to other police forces of a similar size – who receive more cash per person than we do, and patrol smaller geographical areas . This definitely needs to be reviewed.

This year's budget helps to protect frontline policing and provides extra investment in key areas of our work which will help to protect local communities.
