After completing the 26.2 miles last year in surprisingly hot April weather, I am once again planning to run the London Marathon this year on the 28th April.


Some would call it glutton for punishment! This year I have chosen two very worthy causes to raise money for - Corby Mind and Care after Combat; two brilliant charities

What mistakes did the EU make in their relationship with the UK?

I voted to leave the EU and I am not an under-educated, blue collar worker who loathes Europe. On the contrary, I speak very reasonable French and can drive from Denmark to southern Italy without the need of a map – and did so very frequently when I was reporting on GPs in the 1970s.

Equally, I am a citizen of a sovereign state which is ruled by the democratic process. The situation is really no more complex than this. I exercise some control over my life, albeit not that much, by going into a ballot box and making my tick. That's how democracy works.

I am not prepared to be ruled by unelected officials in a foreign country – even if this decision costs me money and reduces the material quality of my life-style.

That the EU did not grasp this single, but immensely important idea, was reflected during the Brexit campaign. Day after day the Remainers brought in experts from every part of the world to lecture the British – and particularly the English – on how stupid we would be to consider leaving what is a political, not trading, concept.

The more the fingers were wagged at us, and the greater the sighs at our perceived stupidity, the stronger the desire to leave became.

I would make two further observations based on the two years I spent working with members of the European Parliament. First, it was the obsession of the EU apparatchiks which caused this whole mess. When David Cameron, the arch Europhile, went to Brussels and pleaded for concessions on immigration the very concept of Brexit could have been killed at birth in one simple move. If the EU had agreed to a cap of 99,999 immigrants a year then Cameron could have strutted into the House of Commons like some conquering hero and there would never have been a Brexit campaign.

Since 100,000 EU immigrants a year were what the numbers were drifting towards, no-one would have suffered. The problem was that EU aristocracy would have lost face – and this was unthinkable.

Secondly, there will be some sort of deal: there always is with the EU, as I know from personal experience. It is the infantile, petty way which things are done in Brussels. There is a much desk banging and threats by very highly paid officials and, at the last minute of the last hour, an agreement is reached because the practical ramifications of not being sensible are too severe.

Ask the Spanish farmer, who exports his produce to Britain and keeps his workers in employment as a result, whether he wants a pragmatic resolution or would prefer to stand up for the EU's political principles. He will be the truly representative voice of Europe.

I feel that I should add that the following statements of fact.

1) Britain is a democracy. It is factually inaccurate to suggest that either our Monarch or the House of Lords can either make or enact law. By virtue of the two Parliament Acts of 1911 and 1949 the House of Lords can neither amend nor prevent the wishes of the House of Commons - but only suggest changes. The Monarch is rigidly apolitical.

What this means in practice is that all eligible voters in the United Kingdom can exercise their democratic rights by voting in each General Election. There is one vote for each eligible voter and no vote is more important than any other. All these votes carry the same weight regardless of the person's age, gender; ethnicity and political beliefs. This is what democracy means.

Now one might think that our MPs are incompetent, ego-centric, narcissistic, even amateurishly dishonest and much more – but they have all been fairly elected by the people of Britain.

I should add that my experience is that some are very good and we should be grateful that they are representing us.

2) I can write directly to my MP and I will receive a response.

I can ask to see him or her in person and will be granted a personal interview.

I know who he or she is; where his/her local office is located and what are the means of reaching my MP.

3) By contrast, the laws and regulations of the EU are made in Brussels by the European Commission and then rubber stamped by the European Parliament. I cannot alter or influence the membership of the European Commission nor can I exercise my democratic rights to change the composition of the Commission.

Those in favour of the EU might not like to be reminded of this situation but it is factually accurate.

4) It is easy for those who are pro EU to suggest that all those who voted for Brexit are some toxic mix of old/ill-informed/poorly educated/parochial or whatever other convenient label can applied to the "mistake" we made in wanting to leave an undemocratic political grouping.

My Grandfather fought in the trenches of the Somme for this freedom and my father made the same sacrifices in WWII. By comparison, what I am prepared to give is mere nothing compared with their sacrifices.

Last year, I was delighted when NHS Corby Clinical Commissioning Group (CCG) announced that Corby Urgent Care Centre (UCC) was to stay open exactly “as is” for the next three years. This was after many months of campaigning as a community, very regularly covered here in the *Northants Telegraph*, and I was pleased that the CCG chose to listen to local people and respect the huge strength of feeling we saw as part of the campaign to keep the UCC open - unsurprisingly well supported, given the excellent level of care provided at the UCC, through a hugely dedicated team of staff.

It was very pleasing, therefore, to hear the CCG announce that they have now successfully procured two new contracts - one relating to the UCC, and the other introducing new primary care services, that I believe are much-needed. This will mean that not only will the UCC service continue “as is”, but a new service, providing 1,000 extra GP related appointments a month will also be on offer to patients.

Residents of Corby, and the surrounding villages and beyond, all know what a brilliant service the UCC provides, and I know that everyone will welcome this announcement as much as I do; not least because of the certainty it brings. Additionally, the delivery of additional GP capacity is great news for our local area. Something I hear often on the

doorsteps is that ease of access for GP appointments is an extremely important priority for local residents, and this announcement will help to dramatically improve that situation, through more capacity and greater flexibility for patients to access those appointments.

In other good health related news for Corby, the Government has recently announced that over 13,000 people aged 55-74 in the town will be eligible for a ‘Targeted Lung Health Check’ - important given the proud industrial heritage of our town, and a further boost for primary care services in Corby.

To my mind, prevention is crucial, and is one of the most significant factors in keeping people well for longer, and it is absolutely right that we invest in our local health services, and that those services best meet local needs. This has been helped by the major boost to NHS spending we are seeing nationally, of nearly £400 million extra a week, which will ensure that the NHS is properly funded, providing excellent care to all, going forward.

Ultimately, I am delighted that the future of our urgent care services has been secured in the medium-term and I will of course be

making the case for these services in the longer-term. We all know what a fantastic service the Urgent Care Centre provides for local residents, and I am delighted that the strength of local feeling has been listened to on this issue, and delivered upon. The UCC represents the very best in health services and is a credit to the NHS as an institution.

I wish the new providers well and look forward to the continuation of an excellent UCC service at Cottingham Road.

defect fixing cycle. People will be able to make reports on the NCC website, where they will find FixMyStreet as the Street Doctor interface – or through the main FixMyStreet website and app. Photos can be uploaded assist with locating issues and reporting back on repairs. They will be able to easily map where the defect is and also view assets such as signs, trees and adopted highways so it is easy to identify exactly which one they are talking about when they make their report to us. Testing of FixMyStreet is happening now. Training will be rolled out in March to everyone. We will also be promoting externally to all our users.

In the last month, we were challenged by the weather but we were ready. Roads were kept clear of ice and snow and safe for drivers.

The progress by NCC to address the financial challenges of the last year has also meant we have revisited the gritting service and introduced a new intermediate gritting network.

The team looked at all the routes from 2018/19, those that had been recategorised to be part of the adverse routes and agreed intermediate routes.

Around 300 kilometres of roads currently on the adverse gritting network will be treated as part of a new 'intermediate' category. The crews will come back in after the precautionary run, load up with salt and go out again.

Consultation on the proposed change to the provision of Northamptonshire Libraries and Information Services

At Cabinet in December, it was agreed to commence consultation on the future provision of libraries in Northamptonshire. The proposals for the final 8 libraries have now been published and so the consultations run as follows:

8 libraries (Abington, Duston, Far Cotton, Finedon, Higham Ferrers, Irchester, Long Buckby, St James) – ended Friday 22nd March

There are proposals for each library, and so people were asked to give their views on an individual library basis, although there was no limit to the number of libraries people could comment on.

They were also able to give their views on the proposals as a whole. Public drop-in events were held in libraries where there is a change proposed, and Councillors were invited to events being held in their divisions. The schedule for these events, along with the links to questionnaires and further information about the consultation, was available on the Consultation Register. The proposals for all 36 libraries will be considered at May Cabinet.

Street Doctor is getting better!

The name's the same but Street Doctor is about to work better for everyone. For many years, our online reporting has allowed customers to tell Northamptonshire Highways about a transport or highway issue directly, and to see what we are doing about it. Over the years we have worked with Northamptonshire County Council to look at improving the service and, this year, Street Doctor is getting an overhaul.

After looking at various providers we will be launching the site using FixMyStreet at the end of March and this will sit on the Northamptonshire County Council website. This means customers will still go to Street Doctor which will take them to the reporting system for a smooth, end to end service.

The system we had been using is getting dated and we have listened to what people really want from a public reporting system. Our officers are already using it internally and finding the whole process a lot better.

Constituents will have a better way of reporting and will see a great improvement in the whole

THE PRIME MINISTER'S STATEMENT ON BREXIT—20th MARCH 2019

Nearly three years have passed since the public voted to leave the European Union. It was the biggest democratic exercise in our country's history.

I came to office on a promise to deliver on that verdict. In March 2017, I triggered the Article 50 process for the UK to exit the EU – and Parliament supported it overwhelmingly. Two years on, MPs have been unable to agree on a way to implement the UK's withdrawal. As a result, we will not now leave on time with a deal on 29 March.

This delay is a matter of great personal regret for me. And of this I am absolutely sure: you the public have had enough. You are tired of the infighting. You are tired of the political games and arcane procedural rows. Tired of MPs talking about nothing else but Brexit when you have real concerns about our children's schools, our National Health Service, and knife crime. You want this stage of the Brexit process to be over and done with.

I agree. **I am on your side.** It is now time for MPs to decide.

So today I have written to Donald Tusk, the President of the European Council, to request a short extension of Article 50 up to 30 June to give MPs the time to make a final choice. Do they want to leave the EU with a deal which delivers on the result of the referendum – that takes back control of our money, borders and laws while protecting jobs and our national security? Do they want to leave without a deal?

Or do they not want to leave at all, causing potentially irreparable damage to public trust – not just in this generation of politicians, but to our entire democratic process? It is high time we made a decision.

So far, Parliament has done everything possible to avoid making a choice. Motion after motion and amendment after amendment has been tabled without Parliament ever deciding what it wants. All MPs have been willing to say is what they do not want.

I passionately hope MPs will find a way to back the deal I have negotiated with the EU. A deal that delivers on the result of the referendum and is the very best deal negotiable. I will continue to work night and day to secure the support of my colleagues, the DUP and others for this deal.

But I am not prepared to delay Brexit any further than 30 June.

Some argue that I am making the wrong choice, and I should ask for a longer extension to the end of the year or beyond, to give more time for politicians to argue over the way forward. That would mean asking you to vote in European elections, nearly three years after our country decided to leave. What kind of message would that send? And just how bitter and divisive would that election campaign be at a time when the country desperately needs bringing back together?

Some have suggested holding a second referendum. I do not believe that is what you want – and it is not what I want. We asked you the question already and you gave us your answer.

Now you want us to get on with it.

And that is what I am determined to do.

If we could select five other events each year such as St. George's Night, a country house reception, a President's or Chairman's dinner, a special dinner on a winter's night and a garden party and build these up over the years, as Ann has done with the Christmas Dinner, we could have a sound source of funds, which would need adapting with the changing years, but would be the bedrock of our social activities. In the words of the old Irish saying, if I were going to Dublin, I wouldn't start from here.

And if I were going to cancel Brexit, I wouldn't start from here either. For me, The European Union has been going in the wrong direction at least since its foundation at Maastricht a quarter of a century ago. Yet until the 2016 Referendum, I, like all those others who felt the same way about it, had been given no opportunity to vote for an alternative.

This is because the EU is fundamentally, and designedly, anti-democratic. It was conceived by elitists who believed they knew best and therefore had the right, nay duty, to dupe and over-rule the common man.

It has embarked on a project to federalize Europe whether Europe's citizens like it or not and to ride roughshod over all objections, over all diversity of cultures and over national independence.

In the vestibule of the Visitors Centre of the European Parliament, are inscribed these words:

"National sovereignty is the root cause of the most crying evils of our times....The only final remedy for this evil is the federal union of the peoples."

At the EU's heart is an unelected bureaucratic dictatorship that has the sole right to initiate legislation. It interprets the treaties to suit its own ends. None of these bureaucrats can be removed mid-term except by the preposterously cumbersome method of The EU Parliament removing them all. They delight in over-regulation by process instead of simple regulation by outcome. This makes them the allies of big business and the enemies of economic vibrancy, of start-ups and of new technology. This is essentially why the EU experiences such very slow economic growth.

Most egregiously, they deliberately introduced a common currency which any sensible economist knew could not function without a raft of non-existent federal institutions.

These consequential extra measures, on their own merits, might not have been publicly accepted but, as expected, they had subsequently to be introduced to prevent the collapse of the jury-rigged system. Another nail in the coffin of members' sovereignty.

To protect the badly-administered banks of Germany and France, this inefficient system condemned Greece to poverty and destitution. It nearly achieved the same in Italy and Portugal. The chaotic single currency can and will result only in the collapse of the EU or its total domination by Germany.

In short, there is nothing the EU can do that would persuade me to support it. As a democrat, I cannot endorse a system that subjugates democracy to elitism. If the necessary reforms were to be implemented The EU would cease to be The EU. It is a rare empire that successfully and voluntarily transforms itself into a commonwealth.

The EU is a badly-conceived idea whose time came and went half a century ago.

RAY JACKSON—MORE THOUGHTS ON LEAVING EUROPE

With the the threat of a major crisis hanging over ourselves, our political party and our country and the drama of being aware that people of goodwill could still save the situation, it is good to try to articulate some of the issues which will end our existence as a responsible, well governed country with about 1000 years experience. There will be a lot of blame so a few headings might be helpful.

Financially we can expect GDP to fall by about 25%. The amount will depend on how thoroughly our business rivals seize their opportunities to push us out of our traditional markets. We know already Germany wants to stop making and supplying components to British Aerospace because the completed assemblies are being sold to Saudi Arabia. Once properly separated, Germany will change its mind and make and supply the whole assemblies. After years of struggle and hard work to build a world leading company, we will see it taken from us. Some economists have forecast an exchange rate of US\$1.1/£1. That should restrict the import of carbon fuels and please the Green Party as well as restricting the import of American high tech products such as aircraft. The economic outlook could be grim.

Politically, the calling for a second referendum challenging 17.4M people their right to leave is totally un-British and undemocratic. We just do not do things like that in Britain. We stick by what people vote for. My immediate reaction a few weeks ago when it was sort of gradually becoming Momentum policy had me planning to give up politics, leave the Conservative Party and gently rot away. The problem is that most Brits share my revulsion at such a move and will be prepared to go down with honour, supporting democracy and saluting the ensign as we sink beneath the waves. It was heartening to hear that Tom has the same opinion but expresses it probably better. What motivates the DUP is impossible to understand.

Put in a position with power, they seem to be determined to sell it for as much as they can get, regardless of the needs of the Conservative and Unionist Party. With friends like these who needs enemies? Much the same goes for the ERG Group. They are all highly intelligent and successful people, the sort I admire for their potential to govern us well. Yet they split hairs over the PM's agreement with the EU and deprive us of their leadership. Do they really think their calculation that there are a few too many angels dancing on the head of a needle will matter in 5 years time?

One group which I am finding more and more difficult to watch are those new young members who came in at the last election. Every interview is the same. 'Theresa May has no idea and has wasted three years when she should have been negotiating. She has blinkers and refuses to listen to our arguments. It is her fault the country faces ruin'. Young Tories (except of course Tom) are the same. It is so refreshing to hear Ken Clarke or Hilary Benn or some other senior politicians who gave up personal vituperation as they became 'good' MPs. If, as I fear, many more of these inexperienced youngsters will be brought in by Momentum at the next election to replace our Tories who will have to accept the blame for ruining the country for the next two decades. The question is whether the Party will survive.

I must say I favour the PM's deal. We avoid so many dangers. The situation is never static. If we can rid ourselves of those who are trying so hard to ruin us, we will have enough wit and energy left to establish the working relationship we want with the EU. I remember being bombed and machine gunned by German aircraft in Peterborough in the 'forties. At least thanks to the EU I no longer have to shout, 'Don't worry - it's one of ours' or wince when I hear a siren.

POLICE AND CRIME COMMISSIONER STEPHEN MOLD



6 Mar 2019

This year's budget for policing has not been an easy one to set as we face the ongoing challenge of balancing the needs of an ever increasing population with a flawed funding model that effectively means that Northamptonshire Police loses out on much needed investment when compared to other forces.

I am pleased that the Government have now recognised the serious funding issues that face policing today. However a great deal of that burden will be passed on to local residents through their Council Tax Bill.

This is one of the hardest decisions I have had to take as the Police, Fire and Crime Commissioner and one that I do not take lightly, even though 58% of people who responded to the budget consultation said they would pay more for policing.

For less than 50p a week extra, this budget will mean that this is the third year in a row that the police budget has increased and means that the operational policing budget in 2019/20 is £130 million. This is an increase of £11.6 million since 2018/19 and almost £20 million since 2017.



£3 million of this will be specifically ring-fenced to be spent on improving police visibility and service in areas that residents have told me are a priority.

Improvement plans which the Chief Constable and I will announce will include:

- A significant investment in neighbourhood policing, including more dedicated police officers and staff
- An improved response for victims of burglary and a renewed focus on the prevention and detection of crime
- Additional resources to tackle crime and bolster the rural crime teams to support policing in rural areas
- Greater focus on tackling street level drug dealing and anti-social behaviour

This will build on additional funding given in the previous two years, including for the investigation of domestic abuse and sexual offences and the funding of an additional 50 frontline police officers and staff. All of this has been achieved by an increase of less than 50p a week. I will make sure that this increase leads to a better service for local people and I will be working with the Chief Constable to demonstrate how improvements are being made.

As the first Police, Fire and Crime Commissioner for Northamptonshire I am also responsible for setting the budget for the County's Fire and Rescue Service. My first budget represents the first year of a three year plan to build financial stability and includes some immediate initiatives for Fire and Rescue to take forwards, including:

- 2% pay inflation has been included and estimated for all staff
- A three year investment plan to ensure the service has sufficient reserve levels and a Reserves Strategy in place.
- Funding has been set aside in the Fire budget to contribute towards the cost of Governance transition over three years.

The first specific Fire capital programme has been prepared to invest, develop and provide the infrastructure needed to support the delivery of future Fire services.

A draft capital programme has also been prepared which will be reviewed and refined during the year.

In response to my consultation, 70% of people said that they would pay more to support Northamptonshire Fire and Rescue Service and my ambition is to provide a stable platform that will enable them to plan improvements in the service that the public receive. I have been able to deliver a balanced budget for 2019/20 where all funding for Fire is allocated to support Fire delivery and only increased the fire precept by just £1.76 a year.

Serious and violent crime is at the forefront of many people's mind at the moment. Operation Viper was launched last year to help focus attention on tackling people who commit serious crime in this county, like gang-related violence and drug crime, modern slavery, human trafficking and the grooming of vulnerable people.

Over the course of 12 days of action, police seized drugs, weapons and cash and arrested 38 people for offences linked to serious and organised crime.

The Force's proactive teams were also heavily involved in tackling serious and organised crime, and during 2018 they:

Made 514 arrests
Searched 269 premises
Conducted 767 stop-searches
Seized 172 vehicles; 141 weapons;
£196,000 cash
Seized drugs worth almost £150,000
including heroin, cocaine, crack
cocaine, cannabis and amphetamine

In addition to this, I gave the Force an additional £63,000 to tackle serious and organised crime, which paid for 12 further days of action.

The consequences of serious and organised crime can be seen right across our county and

tackling the problem is, without question, a key priority for Northamptonshire Police. I will support the force in every way that I can so that they can focus on fighting this criminality.
