Dear Members,

By the time you read this, our Party will have a new Leader, and the country will have a new Prime Minister.

Having attended the official Hustings at the ICC in Birmingham, I can say that we are lucky to have both candidates in our Party – indeed we are lucky to have all of the leadership contenders. At the West Midlands hustings both candidates spoke well, both answered questions and both were clearly dedicated to the Conservative cause. Similarly both received a rapturous round of applause after their speeches, and both received lengthy standing ovations.

What the new leader needs to do now, and do urgently, is begin the process of bringing the Party, and eventually the Country, back together. It's an incredibly tough task, but hopefully one that will be made easier once Brexit is delivered. If we manage to leave on the 31<sup>st</sup> October, the process of healing and recovery can begin in earnest on 1<sup>st</sup> November.

One thing we do know – if a General Election is called, we are going to have a fight on our hands. Lose that fight and we could easily have a Jeremy Corbyn led Government / Coalition Government – maybe even a Labour / SNP one.

It is vital that we get organised and come together as an Association and a Party.

**Irthlingborough By-election.** Due to the resignation of a Labour District Councillor in Irthlingborough, there is a by-election. These are unpredictable times and not ideal for by-elections, so we need as much help as possible in delivering leaflets and canvassing to identify our voters. Labour have been out in force already, and chatting to them on the street, they didn't hide the fact they thought Irthlingborough was a seat to win on their way to Corby and East Northants.

**Town and Unitary elections.** Next year will see elections for Town and Unitary Councils. As such CENCA needs to collate a list of approved members who would like to be considered for a local government position. You should already have



received an email or letter from Ann asking you to let us know if you are interested, if you haven't, please contact Ann at the office. Once we have collated a comprehensive list, CENCA will organise any required Approvals Committee meetings, before moving on to Selections.

**Reasons to be cheerful.** In my last report, I had mentioned how poorly the Conservatives had performed in the EU elections – disastrously in fact. But there are some reasons for us to look forward with optimism: -

- Feedback from canvassing is pretty good. We are managing to keep hold of most Conservative voters, winning others from UKIP and potentially the Brexit Party, and hearing plenty of stories from Labour voters about how they will never vote again. Considering how long we have been in Government, considering Brexit, and looking at the political landscape as a whole – we aren't doing too badly
- At the time of writing, YouGov (yes I know, who believes Polls!) has the Conservatives on 24, Brexit Party on 23, Lib Dems on 20 and Labour on 18.
- A new Leader. Whilst many will accept that Theresa May did her best under exceptionally difficult circumstances, most will appreciate that something had to change. Hopefully a new leader will breathe new energy into the Party and enthuse downtrodden members.
- Task Forces continue to be well attended, including many younger members of our Party. If you don't already come along on a Saturday morning, please do so. It is a great opportunity to get the latest information from Tom, and enjoy a leisurely walk for an hour afterwards (if you're available) delivering some leaflets.

## SO WILL THE OVER-75s STILL GET THEIR FREE TV LICENCE?

At the moment the cost of providing free TV licences for the Over-75s is met by the government, but from June 2020 the BBC is due to take this over.

Back in 2015 the then Tory Chancellor, George Osborne, and the BBC agreed that the BBC would take on the responsibility of providing free TV licences for the over-75s and in return the licence fee would rise with inflation. These details appeared on the BBC website in July 2015.

Director General of the BBC, Tony Hall, talked about the good deal he had negotiated and confirmed the commitment to free TV licences. He said that the projected annual budget would go slightly up as a result of the inflation-proof licence. But now the BBC Chairman, Sir David Clement says, 'Keeping the existing scheme is untenable and will cost £745 million a year by 2021/22.' We don't know what his fag-packet calculations look like but moving from a slight surplus to a massive deficit smacks of something horribly wrong with his accounting system.

A spokesman for the BBC explained that the BBC had only ever agreed to **take responsibility for the policy** of providing TV licences to the over-75s, and that didn't mean agreeing to pay for them. .

So does '**take responsibility for funding**' mean something different from paying for it. Talk about double-speak

So, sorry for raising your hopes on the front cover but, unless our new PM bails them out I am afraid all the old folk are going to have to hand over to the BBC the £150 per annum pension increase they got in April.

# UK UNEMPLOYMENT FALLS AGAIN TO ITS LOWEST LEVEL SINCE 1974 - AND PAY IS UP TOO -DESPITE BRITAIN'S BREXIT PARALYSIS

The Office for National Statistics has said that the number of people out of work fell by 34,000 to 1.3 million in the three months to April.

The overall employment rate of 76.1 per cent is also the joint highest total since records began in 1971.

There is also a record number of women in work in the UK - with 72 per cent in jobs - this is the highest ever level in Britain.

And average earnings increased by 3.1 per cent compared with 3.3 per cent in the previous month.

The UK's unemployment rate is now lower than at any time since the end of 1974.

The buoyant figures show Britain's economy still defies the Brexit paralysis and seemingly unending deadlock at Westminster.



## GREEN MEP DISCOVERS THE REALITY OF BRUSSELS

They say you should never meet your heroes, new Green Party MEP Magid Magid appears to be having exactly this experience in Brussels after discovering that the EU that he was passionately in favour of just a few weeks ago is actually a bureaucratic hellhole dominated by stale old white men stitching everything up behind closed doors. *Brexiters did try to warn him*

Magid even suffered the indignity of being asked to leave the Strasbourg Parliament by someone who assumed he wasn't meant to be there because of the colour of his skin - the UK remains the only country to send ethnically diverse MEPs to the European Parliament in any significant numbers. *He's written a refreshingly honest account of what he actually found in Strasbourg and Brussels:*

*"Next to nobody in Brussels has any clue what the European Union truly stands for – beyond a flag and an anthem – and more crucially, where it is heading. And that includes the EU leaders and senior officials soullessly waddling through the corridors of power.*

*When I arrived in the EU capital, I expected to find it brimming with activity and potential answers to these questions. Instead, I felt duped: Making a tangible impact on constituents' lives is apparently not what being an MEP is all about."*

*"In Brussels in particular, we need more transparency in the way we make decisions. Our institutions are plagued with convoluted customs, hidden handshakes and backdoor bargaining. I've seen it first hand already. How can we reject the accusations leveled against the European elite that we are out of touch, when the top dogs in our Parliament and Commission are chosen through obscure quid-pro-quo arrangements agreed over Champagne and truffles in Brussels' finest hotel lobbies?"*

*"In Brussels, the go-to answer to a failed system is superficial; try a fresh coat of paint on crumbling walls. We have to be ready to burn down the house if necessary, to rebuild it in such a way that every citizen from Mansfield to Milan truly feels part of and represented by the EU."*

## Housing, Housing, Housing

It's the Housing Market Stupid, to paraphrase an American politician.

Or we could just say Housing, Housing, Housing.

Amongst the many areas that we Conservatives have to step up our game is housing.

The simple thing is we have to reduce the cost of housing. Too much of earnings is going into housing and not being active in other parts of the economy the parts that create jobs. I'm particularly addressing younger home creators. I speak of home creators and not owners because the cost of buying your first home has risen much faster than wages. Many of us middle aged Tories have benefited from the increase in house values and to be perfectly honest we haven't done anything amazing to contribute to that increase.

Basically, demand has outstripped supply which leads to rising prices. Some may think that's a good thing but I always ask this question – Who is buying my house off me? Answer - My kids. Next Question – Can they afford it? Answer – Maybe, if they have a job paying well above the minimum wage. But in reality, it's massive wealth transfer from the young to the old. Help-to-buy is not the answer, putting more money into the market will only increase prices. In fact, Corbyn's £10 per hour minimum wage will not solve the answer either, it will just add to the housing cost inflation. Maybe the answer is to rent. NO! renting is dead money. The winner is the Landlord and these days that's a private landlord. Mrs Thatcher's Right to Buy policy was the right thing at the time but successive governments have failed to replace the lost low-cost housing stock. Since 2004 unskilled wages have stagnated and with an increased population more people are chasing fewer homes. A double Whammy. Historically

rents over a lifetime were lower than paying a mortgage and this made up for the fact you didn't own the property. Perversely today private rents are higher than the mortgages the landlords are paying.

We don't want a housing market crash that benefits nobody as it's usually accompanied by a recession. But we need two things, housing values increasing at or below wages and a large expansion of affordable council housing.

Why council housing and not private build? Well, private builders have had long enough and under-delivered and if they do build, they squeeze the affordable housing element to a minimum. As Conservatives we should not be hung up on home ownership, that is the choice of the individual, but we should be champions of decent affordable housing be that a home you own or rent.

With enough council housing an anchor on rents can be achieved, not rent controls but a method of damping private rent increases. Most private landlords are responsible but let's not forget they are out to make a profit and are not charities.

The next leader of the Tory party should signal a massive Council house building program if not then they are stupid and we will continue to lose support from younger voters.

## Stewart Binns

After earlier careers as an academic, teacher and soldier, Stewart moved into broadcasting thirty-five years ago, joining Documentary Features and Current Affairs at the BBC, where he worked on *Panorama*. He then spent twenty years at IMG Media where he conceived two ground-breaking series, *Trans World Sport* and *Futbol Mundial*, both of which remained in production for over thirty years.

Stewart directed the *Camera of Record* at each Olympic Games from 1994 to 2004 and produced *Olympic Century*, the IOC's official centennial history. His list of definitive sports programming also includes *Wimbledon*, *A History of the Championships*, *The People's Game*, FIFA's official history and *Tiger*, the official biography of Tiger Woods.

Stewart led IMG's diversification into factual programming with *Artworld*, *Century*, *Churchill* and *The Second World War in Colour*. His 'In-Colour' genre went on to include, *'Britain at War'*, *'Japan's War'*, *'Anzacs'*, *'D-Day'* and *'Canada at War in Colour.'*

In 2004, he became Head of Production at Octagon CSI where he launched, *Golazo!* and *The Football League Show* and widened Octagon's portfolio to include the entertainment series, *What Price Fame?* and *Chasing Churchill*.

Among over thirty international awards, Stewart has been awarded a BAFTA, four RTS awards, a Grierson and a Peabody.

In 2006, Stewart formed his own company, Big Ape Media International. Big Ape's productions include *Indochine*, *A People's War in Colour*, *Korea*, *The Forgotten War in Colour*, *Seisen*, *the Rise and Fall of the Japanese Empire*, *Sport Under Threat* and *India, A Visual Homage*. Recent Big Ape productions include *A Journey of Hope*, *Mao in Colour* and *Chuan's Ocean*.

# RAY JACKSON - 'WILL PARLIAMENT BE PROROGUED'

We have all been active in the febrile atmosphere of the last few weeks, talking more loudly than we usually do and being absolutely certain that the person we are speaking to knows we may not be raising the subject again.

I was surprised at the number of people who are still in error over the role of an MP. From when we first read about 'Civics' throughout all our political lives we have always known that an MP is our 'Representative' not our 'Delegate'. We used to use the trade union comparison of the 'delegate' entrusted by the membership on how the vote on clearly defined issues and then report back to the membership. An MP on the other hand studies the issue as deeply as he can, takes into account the general attitude of the Party of which he is a member, the views of his local association, the

## **Margaret Thatcher's prophetic prediction of the Euro's failure**

### **The growth of extremist parties, mass immigration, and unemployment.**

"If the divergence between different European economies is so great that even the ERM cannot contain them, how would those economies react to a single European currency? The answer is that there would be chaos of the sort which would make the difficulties of recent days pale by comparison.

Huge sums would have to be transferred from richer to poorer countries and regions to allow them to take the strain. Even then unemployment and mass migration across now open frontiers would follow. And a full-fledged Single currency would allow no escape hatch.

The political consequences can already be glimpsed: the growth of extremist parties, battenning on fears about mass immigration and unemployment, offering a real — if thoroughly unwelcome — alternative to the Euro-centrist political establishment.

If in addition you were to create a supra-national European federation, and the people could no longer hold their national parliaments to account, extremism could only grow further.

It is time for the European politicians to sit up and take note. Time to stop their endless rounds of summits — summitry is fast becoming a substitute for decision-making — and observe the reality around them.

There is a growing sense of remoteness, an alienation of people from their institutions of government and their political leaders. There is a fear that the European train will thunder forward, laden with its customary cargo of gravy, towards a destination neither wished nor understood by electorates. But the train can be stopped."

## SAD LOSERS

Philip Hammond has given a furious interview to *Le Monde*, in which he attacks Boris Johnson's attitude to Brexit and suggests he would vote against his own party in a motion of no confidence. 'I will take steps to avoid an exit without agreement apart from an explicit parliamentary approval,' he told the newspaper.

He doesn't seem to be taking leaving government particularly well. The ex-Chancellor knows that his time is over and he won't be able to terrify ministers who want more money for their departments, or irritate the Prime Minister by being all fiscally responsible.

It is a deeply irresponsible move from the ex-Chancellor which will cause further turmoil in British politics. Hammond of course isn't the only minister planning to quit before they are fired by the new prime minister. There are around a dozen who want to resign on principle, and the question is really when they plan to do this. Some may not quit immediately, but probably soon.

These resignations may well be people jumping before they are pushed, but they will also set the tone for what promises to be a very fractious few months in the Tory party.

## £20,000 FINE OVERTURNED

Brexit campaigner Darren Grimes has won his appeal against £20,000 fine for spending violations

Mr Grimes, a former fashion student who ran youth Brexit campaign BeLeave, was issued a fine by the Electoral Commission in 2018 for breaching spending rules and making false declarations in relation to a £675,000 donation from Vote Leave.

However, the fine was quashed by the Mayor's and City of London Court in mid July.

The 25-year-old's lawyers told the court that he had filled out the complex and difficult-to-understand campaign declaration forms to the best of his ability.

Judge Marc Dight found that Mr Grimes had tried to meet his obligations to the commission in filling out the forms, and that his actions were not dishonest or lacking transparency.

The original penalty was widely broadcast on the BBC although the appeal does not seem to have been mentioned..

## THE LAUNCHING OF A MOON ROCKET BY INDIA PROVOKES SOME COMMENTS ABOUT FOREIGN AID.

However this is the GOV.UK response:

*The UK no longer gives any money to the Government of India.*

*More than half of the projected £98 million will be invested in Indian enterprises, while the rest funds technical expertise. Together these help develop new markets, whilst creating jobs for some of India's poorest and marginalised people.*



*At the same time, this will also help create jobs for UK businesses, and generate a return for the UK. This is a win for the UK and a win for India.*

*India is fast emerging as a global power and it is becoming increasingly important for the UK's economic, security and geopolitical interests to be their partner.*

*India is due to be the third biggest economy in the world by 2030. This is driven by the size of India's population, which at some 1.3 billion people is nearly 20 times larger than the UK's. But on a per capita basis, India is more than 20 times poorer than the UK (UK 2017 per capita GDP of US\$39,700 is 20.9 times larger than India's US\$1,900).*

*Ensuring that UK aid spending keeps pace with new challenges and the rapidly changing world we are living in is firmly in the national interest. A global Britain is outward looking. We are using our development budget to build a more stable, secure and prosperous world for us all.*

# AT LAST, CORBYN HAS BEEN FORCED BY THE UNIONS TO MAKE A DECISION OVER BREXIT



Corbyn has long held the position of having no decided policy over Brexit. His policy was in order to try to keep Labour supporters on board. Corbyn's ideal line was 'Remain' in the south and 'Leave' in the north; a nonsense of course but he has stuck by this. But now the Unions have called time and he has had to do as he is told. This new policy is planned to pull back those Labour supporters who have abandoned him for either the Lib/Dems or the Brexit Party.

Sky News reports Jeremy Corbyn has challenged the next PM to put their Brexit deal or a no deal exit to a second referendum, saying Labour would campaign for Remain in those scenarios.

The Labour leader announced the shift following a meeting of his top team, having come under pressure from critics to rectify what they characterised as a lack of clarity from Mr Corbyn on the issue.

In a letter to party members, Mr Corbyn said: "Whoever becomes the new prime minister should have the confidence to put their deal, or no deal, back to the people in a public vote.

"In those circumstances, I want to make it clear that Labour would campaign for Remain against either no deal or a Tory deal that does not protect the economy and jobs."

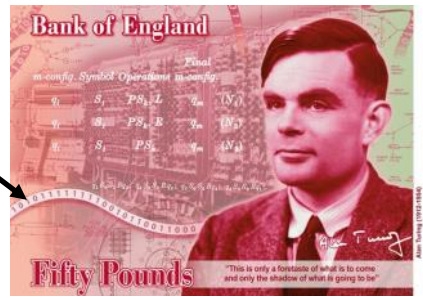

Below is the current understanding of the proposed timeline; this is subject to statutory confirmation –

**Shadow Period** – the Shadow Period (also referred to as the transition period) commences from when the Structural Changes Order (SCO) comes into force and finishes the day before Vesting Day (the day the new unitary authority comes into being). The Shadow Period will commence when the Order has completed its parliamentary process. It should be noted that during the Shadow Period the existing local authorities will continue to operate and fulfil their normal duties and responsibilities.

**Shadow Council Elections** – it is currently envisaged that elections to the new authority will be held on 7th May 2020. Members elected will serve an initial 5year term of office. The first year will be as members of the Shadow Council until Vesting Day (1st April 2021) when the current councils will be abolished and the new unitary council is fully operational. The elections in 2020 are likely to be based on current county divisions, with each electing three Members. There would be a total of 78 Members elected to the Shadow Council. Second elections for the new council are planned for May 2025 (then every four years)

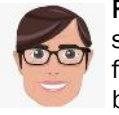

There is an old saying 'If the good do nothing, etc, etc.'. I am a 71 years old disabled female and left my mobility scooter to intervene. Most would say 'How silly ' but I have had a good life - this young male victim is only just beginning. I don't know why he was set upon. I don't care but I can not just watch when such violence is being reigned on to a very defenceless person. Policing must be back on our streets otherwise I can see ordinary people in town and cities will soon be arming themselves , I don't mean just the youths. In Corby we have been totally abandoned by Northamptonshire Police Force.

I, like many others hate going into town, this was my first time since September 2018; it will be a long time before I go again.

# Tom Pursglove, MP on Brooke Weston Trust school opening hours.

I just wanted to say something about the ongoing consultation by the Brooke Weston Trust relating to the opening hours of their schools in Corby, having been contacted by a number of local parents about their

concerns regarding the proposal.

I have of course made urgent contact with the Brooke Weston Trust to get to the bottom of this and to make known the understandable concerns being raised with me about this proposal which is currently being consulted upon, and am very happy to help individual parents raise any specific concerns if they make contact with me directly.

More generally, I have to say that I am surprised by any justification being given on the grounds of funding, as over the two years 2018/19 and 2019/20, per-pupil funding in Northamptonshire is going up by £172, which equates to 4.1% - compared to the national average of 3.2% - and when changes in pupil numbers are taken into account, total funding rises by £30.9 million, which is up 7.1% compared to 2017/18.

Northamptonshire will also receive £27.3 million in Pupil Premium funding, to support the 22,552 pupils eligible for Pupil Premium of all abilities to perform better, and close the gap between them and their peers.

I should also add that compared to 2010, as at November 2017, we had 55 more teachers in Northamptonshire and 490 more teaching assistants compared to 2011. And, on the specific issue of pension costs and salaries, following the welcome end of the 1% public sector pay cap, the Government is funding the unexpected additional cost of the pay award for teachers with £508 million over two years, over and above the amount schools had already been allocated. We are also covering the costs of increased pension contributions for state schools,

and are also taking steps to address some of the areas of particular cost pressure that education has faced.

One of these is High Needs, and Northamptonshire in particular will receive an additional £3.5 million over the two years, bringing the total High Needs block funding for two to 18 year-olds to £71.9 million in 2018/19 and £76.1 million in 2019/20.

Despite having successfully campaigned vigorously for this extra funding, I am conscious that all too often the debate is too focussed on figures and not enough on standards. It is worth remembering, therefore, that in Northamptonshire, three quarters of children now attend schools rated either 'good' or 'outstanding', compared with half in 2010. This decade, we are also on course to create a million new school places, with a big focus on this in our area given the housebuilding we are seeing, following the net loss of 100,000 places nationally in the six years up to 2010. In Northamptonshire, over 17,000 places have been added; this includes the establishment of 10 new Free Schools, with a further five new schools set to be built in the coming years.

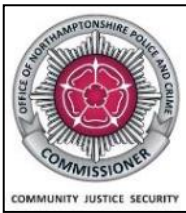
As I say, I am very conscious of the concerns being raised and will do all I can to support parents in ensuring their concerns are properly heard by the Trust, who I would urge to pause for reflection and review their proposals, having taken on board that feedback.

Whilst I am mindful that there is always more to do, significant boosts in education funding locally have been made by the Government, but we must always work together in our community to improve opportunities for every young person to get a good education, drawing upon their particular skills and talents, and help them succeed. As someone who was comprehensively educated locally, I am passionate about this issue, and most recently, I held a meeting only a fortnight ago with local school leaders to discuss a number of issues relating to improving local education that I am assisting them with, and all Northamptonshire MPs meet regularly with the Schools Minister to discuss progress. This is my focus, rather than engaging in political knockabout on this important issue, when the actual figures tell a very different story to the rhetoric seen in some of the reporting on this.

# POLICE AND CRIME COMMISSIONER STEPHEN MOLD



8 Jul 2019

Policing a large county such as Northamptonshire, which contains large urban areas and many smaller rural communities, is a complex and challenging undertaking. With only a finite amount of resources, coupled with new and increasing demands, delivering an efficient and effective police force entails us making some very difficult choices.

To help underline this challenge and enable residents to better understand the work we undertaken on their behalf, a new consultation exercised has been launched by my office. This will help to start a wider conversation about the difficult choices that have to be made when policing the county and about how police resources should be allocated. The consultation asks people to put themselves in the shoes of the Commissioner and the Chief Constable and tell us what matters most to them.



Northamptonshire is growing fast: the population has increased by 115,000 over the ten years to 2017, which is equivalent to adding another large town within the county

border. Policing itself continues to change and become more complex, with police officers responsible for work that isn't always seen by the public, including: monitoring high risk offenders; investigating serious and organised crimes; protecting vulnerable people from exploitation and attending incidents where people are in mental health crisis.

The consultation called, which is called 'Policing - how would you decide' can be completed by visiting our website: [northantspolice.pointsimulator.com](http://northantspolice.pointsimulator.com) and the deadline for contributions is the 30<sup>th</sup> of July 2019.

It is important that we have a wide conversation about local policing in our county. The issues the police are expected to deal with change all the time and become more complex. Despite the fact the Force has a budget of £130 million, tough decisions will always have to be made. Through this consultation, I would like to raise the awareness of some of the work police officers undertake that may not be obvious to most people and I want to hear where local residents think the focus should be.

Policing our roads is one area which I know is of great concern to residents across our county. With this in mind, a brand-new roads policing team has now hit the streets and highways of Northamptonshire to disrupt criminals and make the county safer.

The Northamptonshire Police Road Crime Team is made up of 18 officers who will be focused on denying criminals the use of the roads – disrupting county lines, targeting organised crime groups, responding to Automatic Number Plate Recognition (ANPR) hits and executing planned, proactive operations. The team will work alongside the Force’s Safer Roads Team and the Northamptonshire Safer Roads Alliance to reduce the number of people killed or seriously injured on Northamptonshire’s roads by clamping down on the ‘fatal four’ – speed, seatbelts, drink or drug driving or using a mobile behind the wheel.

Northamptonshire is at the heart of the country’s strategic roads network and making sure that people can travel safely in and through our county is a key priority. This new team that will work to deliver our commitment to improving safety, whilst targeting people who drive anti-socially or use our roads while committing crime.

In addition to this new roads policing team, fifty more police officers from neighbourhood and rural teams have now completed the training and are equipped with Taser, in a first for Northamptonshire. Last year, 100 additional officers were trained and equipped in frontline response and proactive team teams.

Now, officers from the neighbourhood teams will join the number who can deploy Taser, following the investment I made to provide the additional training required. Nationally and locally there has been an increase in knife related crime. It therefore makes complete sense that the officers that are out in the communities are equipped and able to respond to incidents quickly and effectively. Extending Taser capability allows the force to do that.

Northamptonshire Police officers must be able to protect the public and keep themselves safe from anyone intent on causing harm. I was keen to make this investment and support the Chief Constable’s view that training more officers to use Taser will give them a real and visible deterrent in situations where they believe that someone’s safety is under threat.
