## Nicola Sturgeon and the SNP want independence from the UK

They may find this interesting reading:

Chancellor Rishi Sunak has announced the government's continuing policy of support during the coronavirus (and this includes support to Scotland).

'Business support is a devolved policy and therefore the responsibility of the devolved administrations, which will receive additional funding as a result of these announcements in the usual manner:

- the Scottish Government will receive £375 million
- the Welsh Government will receive £227 million
- the Northern Ireland Executive will receive £127 million
- this will contribute to the funding which has already been guaranteed by the UK Government, to continue to provide the devolved administrations the certainty they need to plan for their COVID-19 response in the months ahead
- small businesses in the devolved administrations should also be able to benefit from other UK-wide measures in the government's unprecedented package of support for business, including the various business lending schemes (where the repayment terms were made easier as part of the Winter Economy Plan), and the extension of the Self Employment Income Support Scheme.

It is unlikely that Scotland would have been able to supply this level of funding if it were separated from the United Kingdom.'

## IT'S OFFICIAL—WE CAN CALL OUR FLAG THE 'UNION JACK'

When you see our national flag flying and you refer to it as the 'Union Jack' there is always someone to point out at that it should only be called that if flown from a ship's bow.

The chief vexillologist of the Flag Institute, who is just about the highest authority you can find in the flag world, has declared that, yes, we can after all call our national flag the Union Jack. In other words we can ignore know-all letter-writers who can always be relied upon to go into action every time the term "Union Jack" is broadcast or used in print.

Don't you realise, they say, that the term "Jack" should only ever be used at sea and that on dry land it should always be the Union flag? Well it seems not. Graham Bartram, who undertook research for the Flag Institute, has concluded that the terms Union Jack and Union flag have always been acceptable alternatives whether you are steaming out of Portsmouth on a frigate or hoisting it on the Houses of Parliament.

One of the important pieces of evidence is a 1902 Admiralty circular which declared the terms to be interchangeable: it made no difference whether you called it the Union Jack or the Union flag.

## ELECTIONS IN 2021

A number of elections are due this year. They were cancelled in 2019 due to the impending local government reorganisation and then Covid-19 halted the 2020 elections which were put off until this year.

This year will also be an even bigger effort than usual for Northamptonshire election officials as alongside the local unitary elections, residents will also be casting their ballots for a police, fire and crime commissioner and many will also be voting for the first time for a new town council. Northampton, Corby, Kettering and Wellingborough will all form new town councils, that will take over some public services from the unitary councils.

A joint statement from the West and North Shadow Authorities has expressed some caution about whether the elections will go ahead.

It says: 'We are aware of the May local elections being under review by central government. While we are looking forward to having councillors in place for the new North Northamptonshire Council and West Northamptonshire Council, which will take over the delivery of public services currently run by the county council and district and borough councils across Northamptonshire from 1 April, the number one priority for a local authority is the safety of residents. If the 6 May elections do take place, we will of course ensure that voting follows all Covid-safe protocols in place at the time.'

According to the 6 May timeline the deadline for nominations will be 4pm on 8 April and the final date to register to vote will be midnight on 19 April. The deadline to apply for a postal vote will be 5pm on 20 April.

On 13th January cabinet office minister Chloe Smith said the ballots would take place across the country on 6 May as 'voters have a right to be heard and to decide who governs them'.

She said: 'There would be additional Covid-19 safety measures put in place at polling stations and the government is actively encouraging anyone shielding to apply for an absent vote. There was however a caveat in that the decision would be 'under review', but the minister said there would have to be robust evidence if a cancellation was decided.'

## CORBY COUNCILLOR DAVID SIMS REPORTS ON RECENT PLANNING NEWS IN CORBY

5 Jan 2021

The fight continues regarding Oakley Park Gypsy site, Ashley Road, Middleton.

A breach of condition notice served has finally been served.

The Senior Planning Enforcement Officer served a Breach of Condition Notice (BOC) on the above site this afternoon.

There are two requirements on the notice and they are:

1. Remove all static and mobile homes from the site apart from the 3 in total as approved by the planning permission,
2. Remove all touring caravans from the site apart from the 3 in total as approved by the planning permission.

The compliance period is 6 months from 11 December 2020.

The notice has been served on the occupiers of the site and each mobile on site has been served a copy.

Copies have also been posted on the two accesses to the site in accordance with formal guidelines.

6 months compliance period was imposed due to legal advice after the government announced that immediate eviction should be avoided during the Covid-19 pandemic.

This is a retrospective application 20/00097/COU located off Ashley Rd Middleton opposite the Middleton waste-water treatment works. The Environmental agency initially responded with no comments as it did not fit any criteria on their consultation checklist.

However after a second time of asking and raising the issues of the sewerage and of course the history associated with the site they then



responded again this time objecting because it involves the use of non mains foul drainage where it is reasonable for the development to be connected to a public sewer. *(The reason for this is private treatment facilities should only be utilised when it is not reasonable to connect to a public sewer. This is because of the higher risk of failure leading to pollution of the water environment posed by private sewer in comparison to a public sewer.)*

David Sims moved a motion against the officer recommendation of approval based on the objection from the environmental agency. Despite the fact CBC cannot currently demonstrate 5 year land supply for travellers which in David's view is completely unacceptable as this should have dealt with some time ago. This is now going to appeal in which David will have to give evidence to defend his reasons. His hope is now we can have the appeal heard after vesting day of the new unitary authority as we may then be able to demonstrate we have 5 year land supply for travellers. This will of course strengthen our position in the appeal.

The same argument had to be used with Anglia Water on the Larratt Road Weldon planning proposal which was successfully refused.

(25 Jan 2021) Here is the latest information regarding travellers on Peasdale Hill Field located along Ashley Rd Middleton.

David has suggested, and this has been agreed by the legal department, for an enforcement and stop notice rather than an injunction. This is because the injunction would take several days to collate and then we would have the issue in regard to the possible delay at the Courts. An injunction would also only effectively freeze what has taken place on the land whereas the requirements of any enforcement notice will require that the land is vacated and restored. The stop notice will prevent any further operational development.

Ray Jackson, a former councillor for Great Oakley, used his community fund to have a notice board and bench installed on Lewin Road. The bench is regularly used especially by the elderly as a rest point but has now sunk down one side due to unstable foundations. The notice board is also damaged. David Sims has asked the CBC to carry out repairs on these items.

# COUNCILLOR KEVIN WATT, LEADER OF CONSERVATIVE GROUP ON CORBY BOROUGH COUNCIL

Brexit has finally happened and we're all finding out what it actually means. So far I gather that Dutch Customs will inspect the contents of your sandwiches throwing out any ham. *Note to self: if travelling to Holland pack egg mayonnaise sandwiches.*

The French customs are insisting on grammatically correct paperwork even down to missing full stops. Ardent vocal remainers would have us believe that this is the situation forever. I'm sure this silly season will settle down and sanity prevail.

Strangely it's reported that increased import paperwork will add £1.50 to a bottle of EU wine. Excellent wines from outside the EU presumably already have these charges applied meaning the wine itself must be cheaper. Anyway French wine producers are going to have to sharpen their pencils if they want to compete on the British high street.

Maybe the biggest fallout from Brexit is Nicola Sturgeon's drive to extract Scotland from the Union. This would be the strangest of ironies as Scotland formed a Union with England because it was broke. Should Scotland leave the UK it would have the biggest deficit in Europe, essentially broke.

Its current account deficit is worse than Greece when the EU imposed draconian cuts to its public services. All the free stuff Scotland currently enjoys by way of the Barnett formula - the free prescriptions, free adult social care, free university education - would have to go or taxes would have to rise.

Support for independence currently sits at 54% but some of that has to be an anti Boris sentiment.

You have to give Nicola Sturgeon credit for creating an anti English atmosphere. She even tried to say Scotland was nearly free of Covid but English visitors re-infected Scotland. The truth is an independent Scotland would have to make difficult decisions of either cutting public services or large tax hikes to pay for those services. The party that introduces those policies is unlikely to win the following election.

As Scottish independence affects the Union perhaps all those in the Union should have a say. It's very likely in the current anti English climate fostered by the SNP that English voters would do their work for them and eject Scotland from the Union. But that should not happen because the SNP is not Scotland. Those that draw similarities with Brexit are wrong, Scotland and England have much deeper and longer ties than the UK had in the Common Market. We share an island, share a currency, share defence forces and much more.

Perhaps it won't come to an illegal referendum: the Alex Salmond inquiry could be Nicola Sturgeon's downfall because the SNP may not be Scotland but Nicola Sturgeon is the SNP.


So we're throwing absolutely everything possible at this unprecedented rollout.

# Northamptonshire PFCC Stephen Mold's Newsletter

23 Dec 2020

*This issue I would like to share with you details of a multi-million-pound dark web drugs operation for which the crime gang were sentenced for:*

- £2.7million dark web drugs operation
- Cocaine, MDMA, Crystal MDMA, Amphetamine, Cannabis, Ketamine
- Royal Mail used to send drugs to customers
- First ever electronic seizure of cryptocurrency

Four men have been sentenced to a combined total of more than 34 years in prison after their multi-million-pound dark web drugs operation was thwarted by Northamptonshire Police.

Vladislavs Cvirkovics, aged 28, Filip Hmelnicenko, aged 31, Denis Potapenko, aged 28, and Edgars Pirants, aged 32, all pleaded guilty to conspiring to supply Class A drugs at court hearings earlier this year.

The convictions relate to a sophisticated multi-million-pound drugs operation the gang of four operated from Northampton, where customers would buy drugs from them on the dark web using cryptocurrency. The gang would then distribute the drugs via the postal service, both nationally and internationally.

A ground-breaking investigation into the gang was conducted by the Force's Serious & Organised Crime Team following police identifying and searching a storage facility in Northampton in June 2019. Once inside, they uncovered £2.7million of Class A drugs including 3.7 kg of cocaine, 50kg of MDMA tablets and Crystal MDMA, along with Class B drugs - amphetamine, cannabis and ketamine.

The team of detectives were able to link this facility to Hmelnicenko and Cvirkovics who were arrested in Oxford Street, Northampton, a short time later.

Specialist examination of their devices allowed detectives to identify that the pair were marketing and selling their drugs on the dark web through a platform they had named 'MartinLutherUK' on the Empire Market.



Previous customer orders, address lists and images of drugs were all uncovered.

Virtual wallets containing cryptocurrency were also discovered with Northamptonshire Police making their first ever electronic seizure of cryptocurrency accrued from the sale of drugs.

Detectives also analysed CCTV which showed Hmelnicenko carrying large amounts of jiffy bags to numerous post offices in Northampton and using the Royal Mail to distribute the drug orders via the postal network.

Evidence also led police to an industrial premises in Moulton Park where they discovered a large and sophisticated cannabis grow linked to both men, with a street value of £400,000.

However, the case wasn't to end with the imprisonment of Hmelnicenko and Cvirkovics as the dark web shop reopened and once again, became active in the selling and distributing of Class A drugs.

The reactivation was linked to Potapenko who was arrested in February 2020 in Hood Street, Northampton. He was found in possession of digital devices that linked him to the continued operation of the 'MartinLutherUK' platform along with communication linking him to the multi-kilo importation of Class A and B drugs.

His fingerprints and DNA were also found on packaging of the £2.7million drugs from the storage facility and the cannabis factory in Moulton Park.



Spreadsheets found on his computer identified Pirants as also being involved and he was arrested in March 2020 in Cotton End, Northampton. Upon a search of his bedroom and an associated outbuilding, Class A drugs, jiffy bags, Royal Mail special delivery labels, 144,000 MDMA tablets and a pill press used to manufacture the tablets, were all seized.

On Friday, December 18, Cvirkovics was sentenced to ten years for conspiring to supply Class A drugs. He was also sentenced to six years for conspiring to supply class B drugs and one year for the possession of a stun gun, to be served concurrently.

Potapenko was sentenced to six years and eight months for conspiring to supply Class A drugs. He was also sentenced to three years for conspiring to supply Class B drugs and ten months for the possession of CS spray, to be served concurrently.

Pirants was sentenced to seven years for conspiring to supply Class A drugs.

Hmelnicenko is due to be sentenced in early 2021.

DS Keith Morson from Northamptonshire Police's Serious & Organised Crime Team, said: "I am extremely proud of this ground-breaking investigation which shows in no uncertain terms the capability of this Force to successfully investigate a very sophisticated, 21st century, Metropolitan-level crime.

"This is our first ever successful prosecution of a dark web drug supply and seizure of cryptocurrency, demonstrating that Northamptonshire Police can punch well above its weight in our ability to tackle this type of complex and hidden criminal network.

"The officer who led this investigation, DC Gareth Askew, has worked tirelessly to bring this challenging case to a successful conclusion, and I would also like to pay tribute to other departments across the Force, including Cybercrime, Digital, Financial and Forensic teams, who helped us bring the investigation to a point where all four defendants had no choice but to plead guilty."

Detective Superintendent Lee McBride, Head of Serious & Organised Crime at Northamptonshire Police, said: "This result once again shows Northamptonshire Police's ability and determination to robustly tackle serious and organised crime occurring in our county and beyond.

"The scale of this drugs activity and the advanced tactics utilised by this criminal group are issues more typically associated with larger metropolitan forces and I am really proud of the team here whose work was second-to-none - meticulous, tenacious and committed, ensuring this gang was taken down.

"This detailed investigation and final outcome shows we are committed and have the technical capability, skills and specialisms to deal with new emerging criminality. We will continue to pursue criminals who try to hide behind technology to commit their crimes, relentlessly."

# New laws to protect our History from 'Wokeness'

17 January 2021

Communities Secretary The Rt Hon Robert Jenrick, MP has announced new laws to protect England's cultural and historic heritage.

For hundreds of years, public statues and monuments have been erected across the country to celebrate individuals and great moments in British history.

They reflected the people's preferences at the time, not a single, official narrative or doctrine. They are hugely varied, some loved, some reviled, but all part of the weft and weave of our uniquely rich history and built environment.

We cannot – and should not – now try to edit or censor our past. That's why I am changing the law to protect historic monuments and ensure we don't repeat the errors of previous generations, losing our inheritance of the past without proper care.

What has stood for generations should be considered thoughtfully, not removed on a whim, any removal should require planning permission and local people should have the chance to be properly consulted. Our policy in law will be clear, that we believe in explaining and retaining heritage, not tearing it down.

New legal safeguards introduced for historic monuments at risk of removal

- All historic statues, plaques and other monuments will now require full planning permission to remove, ensuring due process and local consultation in every case
- The law will make clear that historic monuments should be retained and explained
- The Secretary of State able to "call in" any application and ensure the law is followed
- The most significant new protection for England's heritage since the 1967 Civic Amenities Act established Conservation Areas.

Measures build on proposals that embed beauty, design and quality in England's planning system for the first time.

The new legal protections mean that historic statues should be 'retained and explained' for future generations. Individuals who want to remove any historic statue, whether listed or not, will now require listed building consent or planning permission.

Under the new regulations, if the council intends to grant permission for removal of a particular statue and Historic England objects, the Communities Secretary will be notified so he can make the final decision about the application in question.

Culture Secretary Rt Hon Oliver Dowden MP said:

*'I strongly believe that we should learn from our past – in order to retain and explain our rich history.*

*The decisions we make now will shape the environment inherited by our children and grandchildren.*

*It is our duty to preserve our culture and heritage for future generations and these new laws will help to do so.'*

The new rules will also apply to unlisted historic plaques, memorials or monuments which will also require planning permission and Historic England to be informed.



# THE NEW LOCAL COUNCIL STRUCTURE

*In April the Corby Council, together with the district and borough councils in the area will be closed and these will be replaced by two unitary authorities and four new town councils.*

*The elections are due to take place in May this year and residents of Northampton, Wellingborough, Kettering and Corby will then be represented by, not only Unitary Councillors, but by town councillors as well. Every resident in the county will be represented by one of 270 town or parish councils.*

*Early in 2020 shadow councils were set up by outgoing councillors and clerical officers with the aim of taking over from the current local councils once the elections take place. Meetings have been held throughout the past year to ensure that the new town councils are legally in place by April.*

## **The new town councils**

- *Northampton - There will be 25 elected councillors.*
- *Wellingborough - There will be 23 town councillors.*
- *Kettering - There will be 20 councillors elected in May across nine wards.*
- *Corby - The new council will elect 17 town councillors at the May local elections. Talks are ongoing about costs and which services it will run although the borough's leadership has said it wants the initial precept to be 'minimal'.*

*The new town councils will then have to negotiate which services and assets they wish to take on and how much of a precept they wish to levy on their electorate.*

## **Outgoing administration assets**

*All assets such as buildings and parks and service provisions plus those of the county council will be legally transferred over to the North or West unitary council.*

## **Conclusion**

*Unfortunately there is no doubt that residents will end up paying more for the new system. Council tax will be increasing along with the police precept and there will be an additional payment to cover the cost of the new town councils.*

*However, one of the positive aspects of the new system is residents will have a closer relationship with their local authority through the town council scheme and with the two new unitary authorities.*

At the moment within the Corby Borough Council area there are seven parish councils: Cottingham, Middleton, East Carlton, Gretton, Stanion, Little Stanion & Weldon and Rockingham.

Within the East Northants District Council area there are 37 parish councils and 6 town councils.

## VACCINE PROGRESS IN NORTHAMPTONSHIRE

By 8 January 20,000 Northants residents had so far received the coronavirus vaccine according to the county's top NHS boss.

Chief executive of the Northamptonshire Clinical Commissioning Group Toby Sanders said the mass effort by the two acute hospitals, GPs practices and a mobile service has meant that a significant number of the county's priority groups had received the first dose of the vaccine.

He said altogether there are 135,000 in the four priority groups in Northants - which are NHS staff and care workers, anyone over 70 and the clinically vulnerable - and so the county was well on the way to have all of that group vaccinated by mid February.

The first vaccines, which have been the Pfizer vaccine, were provided by Northampton General Hospital in mid December.

He has also announced that a fourth larger vaccination centre should open in the county by the end of January.

We've published our UK Vaccines Delivery Plan which maps out our route back to normality.

We are on track to offer the vaccine to all the most vulnerable groups by the middle of February – and the plan sets out how we will ensure every adult gets access to the vaccine.

We have always known vaccines would be our best way out of the pandemic and we moved fast and early to make sure Britain leads the way on vaccinations.

This action allowed us to be the first country to authorise a vaccine, secure access to 367 million doses and have more authorised vaccines than any country in the world.

So far, our Plan has allowed us to vaccinate over 2.3 million people – more than the rest of Europe combined.

Our plan sets out how we will expand and accelerate our rollout, creating the largest vaccination programme in British history, with:

- 206 active hospital sites
- 50 large vaccination centres
- 1,200 local vaccination sites

All meaning that by the end of the month everyone in England will be within 10 miles of a site or have a vaccine brought to them in highly remote areas.

And by mobilising a workforce of over 80,000 from the NHS, armed forces, and government, with the support of potentially over 200,000 members of the public, we can commit to the following timetable:

- 1) End of January – all residents and staff in over 10,000 care homes across the country will be offered a vaccine.
- 2) February 15th – all those in the top four priority groups, who account for 88% of fatalities, will be offered a first dose.
- 3) Spring – all nine high-risk groups for phase one of the programme (32 million people accounting for 99% of deaths) will be vaccinated.
- 4) Autumn – All UK adults will have been offered a vaccine.

We're under no illusion as to the scale of the challenge ahead, but we have never felt more confident we can achieve our ambitious goals.

# THE MISERABLE OLD GIT - 'THE NHS MUST BE SORTED OUT'

As I write this page, the National Health Service and all those associated with it are in the process of adapting to two seismic events. The first is to deal with the almost overwhelming numbers of patients suffering from Covid 19 which have almost overwhelmed the service since Christmas. To say that this was unexpected is folly. Christmas was nearly allowed to be 5 days of events, Students came home for the holidays and New Year happened. The Government should have shut down the country on about the 15th December for four weeks, and this crisis which is still in the process of unfolding may have been avoided. We should be eternally grateful for the whole of our NHS family forever.

Now we have a very fat cat living in Northamptonshire whose pay increased to £2.02 million per annum for being one of nine Directors at a care home group where many of its homes are classed as inadequate by the Care Commission (clearly a body without teeth). A dividend was also declared for that company of a huge amount when its front-line staff are only earning just over £8 per hour. What is this country thinking about allowing the care of its elders being in the hands of such individuals who don't even do a great job (except for generating profits) judging by results. We must get this sector of our community back under our control as soon as possible to ensure that there is consistency of care and more importantly fees. This Government has pledged to sort this out - and sort it it must! Profit is something for the private sector and this has no part in the future of any part of the Care sector in my opinion.

And then there's education (he says with fire breathing from him) - I'll wait to next time.....


