HMRC Scams

There's a rise in the number of fake HMRC emails going around.

These fake emails will try to grab your attention with urgent language or 'too good to be true' offers. The hooks criminals use will vary, but here are some of the common ones:

- tax credit renewals deadline: 31/07/23.
- · update your records
- a £460 discount offer under the Energy Bill Support Scheme, but you need to add your card details.



Each email will ask you to click on a link and fill in your personal and financial details. The scammers will use time sensitive scenarios in their emails to make you enter your personal details without thinking.

Just remember: HMRC will never send emails about rebates or refunds

Never click on a link in an unexpected email and enter your details

You should always contact HMRC to verify any payment request using the number on the gov.uk website or through your online tax account.

A Happy New Year to you all. It has been a very busy start to 2024, with budgets being set, committees catching up on Christmas backlog, and a by-election in Wellingborough to fight.

Government funding boost for local councils It is no secret that every Council across the country is under financial pressure to deliver the 2 big demand-led services -Adult's and Children's services. Those services tend to make up the majority of a council's overheads. and increasingly difficult to predict. It was therefore very welcome indeed to hear the Government's Levelling Up Secretary announce on 24th January 2024 that a further £600 million local government support package was being launched, with £500 million of that being specifically to bolster social care budgets. This funding builds on the £64 billion package already announced at the provisional Local Government Finance Settlement for 2024-25.

The Minister for Local Government, Simon Hoare, stated "This injection of funding will help ensure services which people rely on can continue – and demonstrates how important we view local government. We have listened to various organisations and considered their views seriously and I'm grateful to those who reached out to me.

The funding offers something for all of our hard-working councils, with additional funding for social care as well as help for rural authorities to deliver essential services."

£500 million The increase in social care funding is in addition to the £1 billion in additional funding announced at Autumn Statement 2022 and July 2023. to enable councils to continue to provide



crucial social care services for their local communities, particularly for children.

Local Culture, Tourism and Heritage

We are very lucky to live in North Northamptonshire, with its open spaces, cultural assets, theatres and historic buildings – all helping to bring tourists and revenue into our region.

Northamptonshire PFCC Stephen Mold's Newsletter



25 Jan 2024

We start 2024 where we left 2023 with the work of the OPFCC being recognised nationally as we work to improve the lives of people across our county. I was very pleased that the success of our bids to the Government's Safer Street Fund continues with the recent announcement that our work with Northamptonshire Police has won a regional award for their work in tackling Violence Against Women and Girls (VAWG).

The National Police Chiefs' Council (NPCC) presented the 'Making Spaces Safer' award in recognition of our joint efforts in making areas in the county safer, particularly for women at night. One such award-winning measure was the introduction of Operation Kayak, a policing initiative to keep people safe on weekend nights out.

Operation Kayak patrols first began as a pilot, funded by the OPFCC, and have proved to be extremely effective at reducing offending behaviour and in safeguarding the vulnerable. The patrols have since been adopted as a core operational activity. Officers working in the night-time economy are briefed to be proactively on the lookout for suspicious activity, sexual aggression, harassment, inappropriate or predatory behaviour

The NPCC award also acknowledged the effectiveness of the Safer Nights Out (SNO) vans, which were set up and funded by my office to be a haven for anyone who needs support while on an evening out. The SNOvans are customised minibuses, staffed by trained volunteers, who give practical help to anyone who needs it.

Preventing violence against women is central to my priorities for this county. We have worked hard with Northamptonshire Police and other partners to put practical measures in place to prevent crime and make people safer in the night-time economy. It is very satisfying that this work has been recognised and is making an impact.

The SNOvans are part of a wide-ranging programme of initiatives that work together to create safer spaces, including enhanced CCTV and better lighting; safer walking routes and funding licensed premises to join the Licensing Savi scheme and promote high standards in venue safety. We have also created the most extensive network of ID Scan technology in any night-time economy in the country, to help premises deter anyone intent on causing trouble. We will continue to work together to tackle Violence against Women and Girls, and to reduce alcohol related crime, violence and disorder and create spaces for everyone to enjoy.

The issue of retail crime and violence and abuse against shop staff is also a growing concern for many across our county. With this in mind. I helped to organise a roundtable discussion to give retailers the opportunity to share their experiences of retail crime in Northamptonshire. meeting, involved representatives of major retail chains. shopping centres and independent stores along with the Northamptonshire Business Crime Partnership. and officers from Northamptonshire Police.

At the meeting we heard about the Police, Fire and Crime policing operation that is targeting prolific Northamptonshire Northamptonshire Business Partnership's two specialist incidents.

The roundtable event ended with commitment from everyone that they would continue to talk together and ensure that the views of businesses and partners are fed into the work to tackle crime and anti-social behaviour. They agreed to meet again within the next six months. This was a very constructive meeting and we have agreed that we need closer collaboration and stronger dialogue to make an impact. The voice of the businesses matters if we are going to be able to improve how we work. and I am meetings such as this will help to strengthen our response to retail crime.

As the PFCC for Northamptonshire, bringing people together to collaborate on combatting serous issues is a key aspect to my role. Recently over seventy-five representatives organisations. from partner community groups and voluntary sector organisations attended an engagement event hosted by Northamptonshire Serious the Violence Alliance (NSVA). The event marked step forward in collaboration to develop a joint response to tackle serious violence and knife crime across the county. As part of the Serious Violence Duty, the NSVA was formed to develop a joint approach to tackling the root causes of serious violence.

While I am saddened to be saying farewell to my previous role as Minister for Disabled People, Health and Work and the brilliant team at the Department for Work and Pensions, I'm proud to have contributed to the crucial effort to enhance the lives of disabled people in the UK. I must say that my passion to deepen inclusion and broaden opportunity is one for life, not just in the ministerial role, and I very much look forward to working on this agenda in other capacities in the years ahead.

Participating in the Home Affairs Select Committee session in my new ministerial role

Only a few days into the new job, I was pleased to appear before the Home Affairs Select Committee, outlining progress and next steps around cutting net-migration, exiting asylum seeker hotels and drastically reducing the asylum backlog, all against the backdrop of the Government's new legislation to deliver on our partnership with Rwanda to help stop the perilous small boat crossings and to break the business model of the evil criminal gangs. I know this complex and difficult issue is a huge priority for the British people and I will do all I can to help the Government to deliver on the promises we have made





It was great to be back at Progress School in Thrapston, to meet their wonderful new Head of School and the dedicated staff team, and of course some of their learners, to talk a bit about my work as your local Member of Parliament and to hear more about how their work is helping to prepare them for their next chapters, finding fulfilling careers they are really passionate about. I was interested to hear about the range of activities they take part in during a school day, including cooking and sports competitions to help build useful transferable skills. They asked some really insightful questions too on a whole range of important local issues, including around policing and the importance of eradicating knife crime and why it is vitally important that Corby continues to produce steel, something myself and people across the constituency are rightly very proud of. They also expressed interest in a range of rewarding career paths, including in construction and education, and I look forward to supporting them moving forward to help ensure that this vital provision continues to go from strength to strength.

It was lovely to celebrate the opening of the new Crazy Hats Waiting Lounge and Garden at Kettering General Hospital last Friday. This is a brilliant new facility, that I know will make a big difference to so many patients and their loved ones locally in the years ahead, making their experience of the hospital all the more comfortable. Crazy Hats has been such a force for good locally over the years, raising over £3.4 million to help support those suffering from breast cancer and their families - and Glennis Hooper, who spearheaded the effort for two decades, is one of the most inspirational people I have ever met, with all of her boundless energy, passion and enthusiasm.

recently had the chance to cover the Adjournment Debate in the House on the issue of tackling violent crime in Battersea, and respond on behalf of the Government, outlining the difference that our additional 20,000 police officer uplift has had in making our streets safer, as well as the significant resources we are putting in behind efforts to get knives and other offensive weapons off of our streets. I know that people here in Corby & East Northamptonshire care so strongly about these issues too, and this continues to be a priority of mine locally, working with policing leaders in our area, as well as for the Government nationally. Indeed, we have more police officers now than at any time in Northamptonshire Police's history, but we must never be complacent in our efforts to make our streets safer and keep people of all ages from harm.

It was fantastic to visit Irthlingborough Junior School to speak to their wonderful school council as part of their Community and Charity Week. It was lovely to hear more about all their hard work volunteering with some local organisations which support people of all ages, from those in nursery right the way through to the elderly, and about what they've learned about democracy here in the UK and the importance of standing up for what you believe in, and how important it is to work with people regardless of their views - something I strongly believe in too! They posed some brilliant (and often quite tricky!) questions, from how our laws are made, to what my office looks like, to name just a few. I also very much look forward to answering the pile of insightful letters some of the students wrote - with them representing the next generation, the future for our local community looks very bright!

Further to my recent work on the A43 crossing in Weldon, in which I wrote to almost 3.000 homes in Weldon and Priors Hall Park, to hear their thoughts the need for a pedestrian crossing on this dangerous and fast-paced

stretch of road. I am pleased to say that I have now collated the results and am so grateful to all those who took the time to share their feedback.

I can confirm that over 98% of all those who got in touch believe that a pedestrian crossing is required between Priors Hall Park and Weldon. with over 97% of residents also believing that this is a medium to high priority issue.

It is very clear then that the A43 presents many

legitimate safety concerns for the majority of residents in the Parish of Weldon, many of whom are elderly, or have young children in their families, and do not feel that the road is a safe or viable place to cross.

This is undoubtedly a significant local issue and I very much look forward to hearing what actions will be taken to address this, and I will be pressing for sensible collaboration between Weldon Parish Council and North Northamptonshire Council to finally see this project through and I have sought a meeting to discuss the feedback in that vein with both in attendance. You can see the results in full above, and I will of course provide further updates as I have them.

Notably, in November, my office received over 1.900 emails from local residents and 1.066 specific new cases were created for individual constituents. Further, in December, my office has received over 940 emails from local residents so far, and 565 specific new cases have been created for individual constituents.

SOME THOUGHTS ON METRICATION AND GOODBYE NAPOLEON COMPLEX

An Act of Parliament passed by Lord Salisbury's Conservative administration in 1896 allowed any trader who wanted to use the metric system to do so but left the choice up to individuals. Traders were permitted to sell their goods in any way they felt was best and as the imperial system was the one known by everyone at the time that is what became the norm.

America went metric at the turn of the last century but, again, didn't make it compulsory and there is no problem there.

However, with the dominance of the EU it was inevitable that their preferred measuring system, i.e., metrication, would be imposed on all member states. And, of course, the local jobsworths made it their business to ensure everyone fell in line. Hence we had the 'metric martyrs' who were prosecuted for having the imperial measure on the scales in larger letters than metric numbers. One wonders what it is in the human psyche that turns ordinary people into little dictators.

We saw this same effect with the No Smoking rules. No doubt this was a good, healthy step but once again we saw the rise of the minor official puffing himself up to become all-powerful. They seemed to take

great delight in persecuting anyone who they felt was not complying fully with the law.

Now the country is out of the EU surely it is time for the government to announce that all metric compulsion in matters of trade should cease.

We still measure distance in miles, in spite of some local councils. Milk is sold in litres with the size in pints clearly stated. Beer is sold by the pint, even in Spain, as that is the most sensible measure and apparently, some new small concessions, such as allowing champagne to be sold in half pints, have been made - but surely the time has come for traders to be allowed to sell goods in any way they think will generate trade.

Weighing machines flip happily from metric to imperial at the touch of a button so where is the problem?

In a survey, up to 80% of respondents thought the metric system should not be rigidly imposed. Let's sack the jobsworths.

Of course, there are some areas where the metric system is better. Engineering springs to mind. Decimal is so much better than fractions and leads to fewer errors.



TOM PURSGLOVE'S THOUGHTS ON HS2

I think the Prime Minister was absolutely right to scrap the second leg of HS2, not least because it frees up £36 billion of funding to make much quicker improvements to transport connectivity in England, including distributing a big portion of the money to local authorities to scale-up repairing potholes, which I know is a big priority locally and allowing the £2 bus fare cap to be extended to the end of 2024.

WHO REMEMBERS THE 'NICE VIEW' TAX?

In the recent past a Labour Chancellor was always looking for new ways to raise tax from the population. He became known as 'the Tax-tinkerer' as he was constantly fiddling with tax rates to increase the income to the Exchequer

He came up with idea (or more likely one of his 'advisors' did) of changing the property rating system. At the time houses were rated with a band letter from 'A' upwards and there was a distinct charge for each level of rating.

CONSERVATIVE POLICY FORUM REPORT

I was delighted to see such a great turnout for the CPF meeting regarding The Future of the Welfare State. Considering that welfare is one of the largest areas of government spending, second only to Health, it was a real privilege to have a wide ranging discussion on the long term future of the welfare state.

A number of excellent points were raised throughout the meeting, with an emphasis on more independent monitoring of all sectors of the welfare state. This included better surveillance of those on benefits and fairer evaluations of those with disabilities. Alongside this, streamlining of the welfare process was called for with faster access to the welfare state for those genuinely in need and reduced levels of bureaucracy to minimise the long term impacts on people wishing to access welfare services. Investment and innovation in technology was widely agreed to be the way forward in managing this transition.

Another key area of debate was pensions. With an ageing population and the current stagnation of the U.K. economy, it was agreed that investment into pensions was needed to avoid a reliance on pensioners continuing to work. To alleviate this issue, the approach of requiring an extra year or two regarding state pension qualification was discussed as well as making the state pension means-tested.

Finally, the issue of mitigating the impact of low U.K. birth rates was raised. Two contrasting approaches with excellent supporting points were shared with the group. Some argued that a low birth rate was good for the country and the environment and that efforts should continue to keep the birth rate low. On the other hand, some argued that a higher birth rate was necessary to ensure the future of the welfare state. Proposals included more house building, better child benefit, and tax incentives for women who choose to have multiple children, similar to the policy in Hungary.

A huge thank you to all those that attended the CPF this time round. The next CPF meeting will be held on Thursday 14th March at 7:30pm at Corby Conservative Club. The topic is "My Policy Story" and will focus on policy in the lead up to the general election. I do hope you can join us.
